City of Greater Geelong Proposed Budget

We have reviewed the Budget and provide this submission in light of the UDIA Geelong Chapter's Barwon Region Strategic Priorities document, which can be found at the below link:

 The allocation for a shared path through Armstrong Creek and the Bellarine Regional Rail Trail aligns with the UDIA Victoria's vision for sustainable urban development and connectivity in the growth areas.

- The funding for land acquisition in Armstrong Creek for Development Contributions (DC) funded projects is also a positive step towards accommodating the area's expansion.
- UDIA Victoria recognises the important role of the G21 and we support Council's decision to re-engage as a member of that organization.
- However, the Committee expresses concern over the lack of focus on affordable housing – a critical issue for the region's socioeconomic balance and inclusivity.
- The introduction of a new landscape plan checking and inspection fee, previously nonexistent, is a further added cost to development which impacts affordability.
- UDIA Victoria urges Council to allocate funds for the preparation of a new Housing Strategy to guide the revision of residential zones, ensuring they meet the community's diverse needs.

In conclusion, while UDIA Victoria supports many aspects of the proposed budget, it strongly advocates for a more pronounced commitment to housing strategies, which are crucial for the well-being and diversity of the Geelong community. UDIA Victoria, through its Geelong Committee, remains dedicated to collaborating with the Council to achieve these goals – fostering a vibrant, inclusive, and sustainable urban environment for current and future generations.
