CEO'S REPORT

The industry has endured another year of challenging economic conditions, subdued consumer confidence and a slow to respond government. The conditions have also impacted UDIA Victoria, which has worked hard to deliver exceptional value to our members, remaining cognisant of the financial pressures on the industry.

POLICY AND ADVOCACY

UDIA Victoria has a strong and practical advocacy agenda that delivers for the urban development industry.

Our focus is targeted, drawing on deep industry and technical expertise.

In the past 12 months, we've shown that our advocacy gets results.

Our standing as the peak body for the urban development industry has never been clearer.

UDIA Victoria is the industry voice with integrity and reason; with credible expertise; with fierce determination; with members at its heart.

Our advocacy priorities are informed by our Board of Directors, policy committees, regional chapters and our broader membership. With over 7,500 individual industry experts as members and over 200 dedicated committee representatives, our advocacy is tested and trusted. We are constantly striving for improved outcomes for industry and the community.

ADVOCACY RESULTS

- Secured an expansion of off-the-plan stamp duty concessions aimed at incentivising new apartments and townhouse development.
 We will continue to fight for an extension of this initiative.
- Achieved government recognition of the important role of greenfield development sector through the release of the 10-Year Greenfield Plan and Developer Concierge. We are calling for a similar plan for regional Victoria and more streamlined PSP planning and post-PSP approvals.
- Advocated for a new townhouse code to introduce a deemed to comply assessment pathway to speed up approvals, increase housing supply, and provide greater certainty to development.
- Brought government and industry together to understand the excessive delays with the CHMP process. Our pragmatic reforms are now under consideration by government.
- Engaged in extensive consultation on reforms aimed to streamline planning processes, identifying and removing the barriers that cause industry uncertainty and drive up the cost of development.
- Secured commitments from Melbourne Water and other water authorities to collaborate directly with industry and remove roadblocks to development that hinder housing supply.
- Reduced development taxes in the new proposed developer bond outlined in The Building Legislation Amendment (Buyer Protections) Bill 2025 to minimise its impact on development. We will continue to advocate for further improvements through ongoing consultation on associated regulations.
- Advocated for clear pathways for developers in navigating the recent rediscovery of the Grassland Earless Dragon and its impact on the development of Melbourne's western growth corridor.

ONGOING ADVOCACY

- With a state election in late-2026 and all sides of politics focusing on housing, UDIA Victoria advocacy has never been more important.
- Our advocacy is effective because it is targeted, responsive, deliberate, measured and strategic.
 UDIA Victoria's advocacy is tailored to each specific issue. We work to ensure that we represent the industry in the most effective and responsive manner.
- Our advocacy priorities for 2025-26 are developed to address the current housing crisis, to reposition Victoria as a premier property destination and to support industry to deliver more homes.

OUR KEY PRIORITIES INCLUDE

Streamlining assessment and decision-making to unlock housing supply. UDIA Victoria remains committed to driving reforms in planning processes to reduce costly delays. We actively engage with government to ensure planning system changes are effective and improve efficiency in referral and utility authority processes to accelerate land and housing delivery. Water authorities, biodiversity, cultural heritage and infrastructure delivery are firmly in our sights.

Shaping sensible building reforms that support urban development. UDIA Victoria supports measures that enhance consumer confidence in the building sector but warns against excessive regulation that could increase development costs. We are extensively engaged with government to ensure reforms, such as the Developer Bond Scheme and additional consumer protection measures, do not create unintended barriers to housing supply.

Fixing Victoria's over-reliance on property sector taxation. UDIA Victoria is advocating for a fairer approach to property taxation that encourages investment in development and housing affordability. The state's over-reliance on property taxes drives up development costs and discourages investment. We will continue to push for reforms that reduce the financial burden on new housing and restore Victoria's competitiveness.

Improving the viability of affordable infill development. UDIA Victoria acknowledges the need to increase housing in established suburbs but stresses the Victorian Government needs to do more to support infill development to achieve this outcome. We are advocating for streamlined planning processes, reduced development taxes and regulatory reforms.

Securing long-term certainty for greenfield growth area development. UDIA Victoria is advocating for an improved long-term strategy for the development of Victoria's growth areas. Ongoing delays to Precinct Structure Plans (PSPs) and post-PSP approvals are stalling housing delivery. We are advocating for government to provide forward-looking infrastructure and planning commitments that enable well-connected, liveable communities.

Timely and cost-effective investment in enabling infrastructure. UDIA Victoria is championing a better approach to infrastructure investment to support Victoria's growing communities. We are advocating for targeted, timely and transparent investment in enabling infrastructure to support Melbourne's newest suburbs, including transport connections, healthcare, education and major utilities.

FINANCE AND INVESTMENT COMMITTEE

PURPOSE

- Explore how taxes, charges and the cost of finance influence the budgets of households and developers purchasing and investing in property.
- Quantify and communicate the impact of the taxes and charges affecting the industry to state government.
- Engage and represent UDIA Victoria members on all matters and issues arising in the finance and investment field of the development industry.
- Consider the nexus between infrastructure funding, delivery and the cost of commuting / access to services for homebuyers.
- Promote better access to finance from various funding streams through increased engagement with the financial sector, and advocate for regulatory and tax reform that will support a healthy housing market.

POLICY PRIORITIES & PROJECTS

Analysis and advocacy on key factors affecting housing affordability and project feasibility including:

- Quantify the impact that state government property taxes, fees and charges are having on housing affordability and the commercial viability of development.
- Review the increases in costs of construction driven by materials and supply chain constraints to demonstrate the delivery pressure that exists in the market. Discuss how these factors are not consistent with tax increases.
- Devise measures to encourage greater investment in social housing, key worker housing and new asset classes including build to rent.
- Address changes to the investment climate and examine how these influence buyers, developers, and the potential for diverse development models and dwelling types.

POLICY PRIORITIES & PROJECTS

- Conduct research to quantify the number of apartments in inner and middle Melbourne that are completed but yet to settle, to use as the basis to advocate for greater support within the infill market as well as documenting the impacts of government policy on development viability.

GEELONG CHAPTER (BARWON REGION)



PURPOSE

- Create an opportunity for open and constructive dialogue between the development industry, councils and referral authorities.
- Advocate on behalf of the industry on planning and development issues in Greater Geelong.
- Advocate to all levels of government on planning strategy and timing, including around the provision of infrastructure and population forecasting.
- Work directly with the City of Greater Geelong to improve planning and engineering approval time frames.

POLICY PRIORITIES & PROJECTS

- Research land supply and advocate to the State Government and the City of Greater Geelong to ensure a minimum of 15 years' worth of zoned land is available for development in Geelong.
- Advocate for Victoria's second largest city, ensuring there are government resources and funding that reflect the level of activity and growth in the region.
- Advocate for a balanced approach to the longterm strategic planning and development of Greater Geelong, including an appropriate mix of infill and greenfield supply.




